



Business Articulation Agreement

between

Brescia University College

and

Notre Dame of Maryland University

I. PURPOSE

Notre Dame of Maryland University, Inc. (Notre Dame) and Brescia University College (Brescia) enter into this Articulation Agreement (Agreement) so that students enrolled in the Business programs listed below will have a clear understanding of how their credits will transfer to Notre Dame:

- Business
- International Business

This Agreement facilitates the transfer of prospective graduates and graduates of Brescia to Notre Dame and provides valuable advising tools for the student's first two years of study. Students need to successfully complete their first two years at Brescia prior to enrolling at Notre Dame to be eligible for consideration under this agreement.

II. ASSIGNED RESPONSIBILITIES

A. Notre Dame will:

- 1. Accept the program requirements that Brescia students complete for the programs as outlined in the articulation documents (course cross-walk document) included with this agreement and as stated in the Notre Dame Transfer Policy.
- 2. Accept transfer-appropriate courses with a grade of "B" (equivalent to a 70% grade) or higher.
- 3. Continue working with Brescia on detailed articulation agreements that provide guidelines on additional program to program transfer.
- 4. Provide online chats and information sessions for Brescia students.
- 5. Review all Brescia students for Transfer Scholarships (award amounts are typically in the range of \$8000 to \$14,000).
- 6. Distribute information on external scholarships targeted to international students.

2. This Agreement may be terminated by either party at any time due to a material default of its terms by the other as long as the default has not been cured within a ninety (90) day period from written notice of the default.

D. MISCELLANEOUS

- 1. This Agreement is not assignable but shall bind the corporate successors of Notre Dame and Brescia.
- 2. This Agreement will not create an employment or partnership relationship between Notre Dame and Brescia.
- 3. No amendment to this Agreement shall be valid and binding unless in writing signed by both parties.
- 4. Notice of any action taken by either party and required to be reported to the other party under this Agreement shall be mailed, certified delivery, to the other party at the address stated below:
